We used the \$10,000 to make improvements to our parking lot we were able to square it up making it wider and longer giving us 5-additional parking spaces.



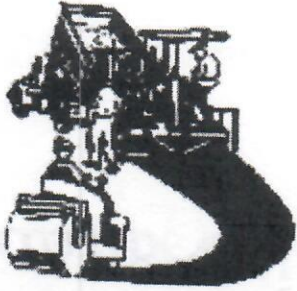
With these improvements our parking lot and driveway is safer, cleaner and we do not have crusher dust tracked into the house and our visitor's shoes are cleaner.
