### HANCOCK COUNTY TOURISM COMMISSION FINAL GRANT REPORT

Where did you place the Hancock County Tourism logos as a sponsor of your event or attraction?

Answer:The Hancock County Tourism and Visitor Center logo was prominently placed in 1) posters hung in places of business around the county; 2) on social media through Facebook and Eventbrite; 3) in print advertising/newspaper ads both in and outside the county; 4) on the thank-you banner displayed in the lobby of the Rick's Theater; and 5) in a half-page ad in our program.

How did you engage/are you engaging the county hotel industry in your event or project? Answer: The LWVHC listed hotels in our invitations to other Leagues, including Marion, Hamilton, Madison, Henry, Delaware, and Allen counties. The LWVHC also encouraged attendees to stay at our local hotels on our program title page (attached). Event posters were hung in Hancock County hotels along SR9 and flyers were left to encourage out-of-towners to attend the event.


